Requirements

1. The criteria for the prize include:
 - i. scientific quality of the work itself
 - ii. broader impact on science
 - iii. importance of the work in the context of healthcare delivery.
2. Papers should be published, at least online, by the deadline.
3. Applicants have to be members of EACPT and must be first, last or corresponding author of the paper.

Application documents

1. An application should include brief statements explaining how the publication meets the above criteria.
2. Candidates must apply using a signed application letter. Supporting information (i.e. CV of the candidate) should also be supplied.
3. Papers must be submitted electronically and must bear the name of the person making the application.
4. Completed and signed nomination letter, together with any supporting information, must be sent to the Secretary of EACPT (asancho.hpth@gmail.com), by the notified closing date: 12 midday CET, March 29, 2021.

The Award will be presented at the EACPT Congress in Athens, June 26-29th 2021.

The Award winner will be invited to prepare a paper for publication in the official EACPT journal, European Journal of Clinical Pharmacology.
